Reservation applications must be sent in with other Exhibitor Applications. Camping fees **MUST** be paid at time of submission of application. Campsite will not be assigned unless camping fees have been paid. **Signing of this application you hereby indicate that you have read the rules and will abide by them and you are 21 years old or older.**

Camping fees are \$15.00 per day for primitive and \$25.00 per day with electrical for a maximum of 5 days. No charge for set up one day prior to the opening of the Fair. Campers must be in place no sooner than this, without prior authorization. All Campers must be removed from the camping site on the day following the close of fair unless otherwise authorized due to any unusual circumstances which may prevail.

Camping is of a primitive type or with electrical hook ups, no water; however water is available nearby. Camping permits must be displayed in an area on the camper that can be readily seen by the person inspecting the campgrounds as well as security personnel.

- **ONLY ONE (1) VEHICLE PER CAMPSITE IN CAMPGROUD AREA.** (Alternate parking is behind the Pumpkin)
- **All Hitches must be readily accessible (for emergency hookup).**
- No dumping of waste water is permitted. Please use dump station.
- Dogs must be kept on leash and observe a quiet period. No walking of dogs within the camp area and all waste must be cleaned up by the person in charge of the animal.
- No open burning is permitted of any kind.
- No sharing of campsites are permitted
- All camp sites must be maintained in a clean and orderly fashion and trash placed in the receptacles provided.
- Youth under the age of 20 years old must be accompanied by a parent or guardian while camping.
- Campers are required to refrain from loud noise and music during the quiet hours when most campers are sleeping (10:00 PM to 6:00 AM)
- Camping space must be occupied by the person to whom the lot is registered.
- All names of the camping party must be attached to the application. Emergency contact person(s) and number(s) must also be listed.
- Notify the Fair Office if you have concerns/problems.
- Maximum of 8 people per campsite
